SASKATCHEWAN REGULATIONS 71/2009

The Planning and Development Act, 2007

Section 205

Minister's Order, dated August 21, 2009

(Filed August 27, 2009)

Title

1 These regulations may be cited as *The Dedicated Lands Amendment Regulations*, 2009.

R.R.S. c.P-13.1 Reg 3, section 6 amended

- 2 The following is added after clause 6(1)(b) of *The Dedicated lands Regulations*, 2009:
 - "(c) a use as a municipal owned water well or as a facility for the supply, transmission or treatment of potable water".

The Stray Animals Act

Section 31

Order in Council 625/2009, dated August 27, 2009

(Filed August 28, 2009)

Title

1 These regulations may be cited as The Stray Animals Amendment Regulations, 2009.

R.R.S. c.S-60 Reg 1 amended

2 The Stray Animals Regulations, 1999 are amended in the manner set forth in these regulations.

Section 3 amended

- 3 The following clauses are added after clause 3(d):
 - "(d.1) any bison;
 - "(d.2) any wild boar".

New section 10

4 Section 10 is repealed and the following substituted:

"Notice of impounded animals if owner unknown

- **10** If a stray is impounded pursuant to section 17 of the Act and the owner of the stray is not known to the administrator, the administrator shall:
 - (a) post a Notice of Impounded Animals in Form E of Part II of the Appendix:
 - (i) at two conspicuous places within the municipality; and
 - (ii) at the livestock auction market at which the stray is to be sold if a sale is required; and
 - (b) send a copy of the notice mentioned in clause (a) to the local livestock inspector or to the nearest detachment of Royal Canadian Mounted Police".

New section 11

5 Section 11 is repealed and the following substituted:

"Notice of sale of impounded animals

- 11 If a stray is to be sold pursuant to section 22 of the Act, the administrator shall:
 - (a) if the owner of the impounded stray to be sold is known, send a Notice of Sale of Impounded Animals in Form F of Part II of the Appendix to the owner; and
 - (b) if the owner of the impounded stray to be sold is not known:
 - (i) post a Notice of Sale of Impounded Animals in Form F of Part II of the Appendix:
 - (A) at two conspicuous places within the municipality; and
 - (B) at the livestock auction market at which the stray is to be sold; and
 - (ii) send a copy of the notice mentioned in subclause (i) to the local livestock inspector or to the nearest detachment of Royal Canadian Mounted Police".

New section 14

6 Section 14 is repealed and the following substituted:

"Penalty against owner

14 Any penalty assessed by the administrator of a municipality against the owner of a stray in accordance with section 21 of the Act is not to exceed \$100 per day for each day that the animal is restrained or impounded, to a maximum of \$2,000 per animal".

1 These regulations may be cited as *The Wildlife Damage Compensation Program Amendment Regulations*, 2009 (No.2).

2 The Wildlife Damage Compensation Program Regulations are amended in the manner set forth in these regulations.

Section 9 amended

- 3 Section 9 is amended:
 - (a) in clause (c) by striking out "utilize prevention measures offered by the department within the meaning" and substituting "use prevention measures offered by the minister responsible for the administration";
 - (b) by adding "or" after clause (d);
 - (c) by striking out "or" after clause (e); and
 - (d) by repealing clause (f).

New section 14

4 Section 14 is repealed and the following substituted:

"Restrictions on payment

14 The corporation shall not make any payment pursuant to section 13 if the producer has not made every reasonable effort to use prevention measures offered by the minister responsible for the administration of *The Environmental Management and Protection Act, 2002*, and all other reasonable prevention measures, to control damage caused by wildlife to stacked hay, silage bales, or honey or associated equipment and brood".

 - (a) was receiving the DHS benefit before the coming into force of *The Disability Housing Supplement Amendment Regulations*, 2009 (No. 2); and
 - (b) as a result of the coming into force of *The Disability Housing Supplement Amendment Regulations*, 2009 (No.2) would no longer be eligible to receive the DHS benefit because the client's monthly rent is less than the minimum qualifying rent set out in Table 1, 2, 3 or 4, as determined on the basis of the variables mentioned in subsections 11(3) to (6), as the case may be.
- (2) Notwithstanding any other provision of these regulations, a qualifying client continues to be eligible to receive the DHS benefit until the client's entitlement to receive the DHS benefit is terminated pursuant to section 32 on a ground other than that the client's monthly rent is less than the minimum qualifying rent set out in Table 1, 2, 3 or 4, as determined on the basis of the variables mentioned in subsections 11(3) to (6), as the case may be".
