**SASKATCHEWAN REGULATIONS 94/2009***The Milk Control Act, 1992*

## Section 10

Board Order, dated October 27, 2009

(Filed October 28, 2009)

**Title**

1 These regulations may be cited as *The Milk Control Amendment Regulations, 2009 (No.10)*.

**R.R.S. c.M-15 Reg 1, Appendix amended**

2 Subsection 3(1) of Part II of the Appendix to *The Milk Control Regulations* is amended by repealing clauses (m) to (o) and substituting the following:

“(m) in the case of class 5a milk:

- (i) \$2.9158 per kilogram of butterfat;
- (ii) \$5.4638 per kilogram of protein;
- (iii) \$0.2505 per kilogram of other solids;

“(n) in the case of class 5b milk:

- (i) \$2.9158 per kilogram of butterfat;
- (ii) \$1.8855 per kilogram of protein;
- (iii) \$1.8855 per kilogram of other solids;

“(o) in the case of class 5c milk:

- (i) \$3.0096 per kilogram of butterfat;
- (ii) \$1.8659 per kilogram of protein;
- (iii) \$1.8659 per kilogram of other solids”.

**Coming into force**

3 These regulations come into force on November 1, 2009.

**SASKATCHEWAN REGULATIONS 95/2009***The Parks Act*

Sections 26, 27 and 35

Order in Council 735/2009, dated October 28, 2009

(Filed October 29, 2009)

**Title**

**1** These regulations may be cited as *The Parks Amendment Regulations, 2009*.

**R.R.S. c.P-1.1 Reg 6 amended**

**2** *The Parks Regulations, 1991* are amended in the manner set forth in these regulations.

**Section 2.1 amended**

**3** **Subsection 2.1(3) is repealed and the following substituted:**

“(3) A notice or document served in accordance with clause (2)(b) is deemed to have been received on the tenth business day following the date of its mailing, unless the person to whom it was mailed establishes that, through no fault of the person, he or she did not receive the notice or document or that he or she received it at a later date.

“(4) In this section, ‘**business day**’ means a day other than a Saturday, Sunday or holiday”.

**Section 6 amended**

**4(1)** **Subsection 6(5) is amended by striking out “clause 5(3)(b)” and substituting “clause 5(4)(b)”.**

**(2)** **Subsection 6(6) is amended by striking out “clause 5(3)(b)” and substituting “clause 5(4)(b)”.**

**Section 67.6 amended**

**5** **Clause 67.6(3)(a) is repealed and the following substituted:**

“(a) file an application with the minister within 60 days after being served with written notice of the fair value assessment of the land that is the subject of the leaseholder’s recreational lease”.

**Section 67.71 amended**

**6** **Clause 67.71(5)(b) is repealed and the following substituted:**

“(b) the fair value assessment of other similar properties in the park in which the land is situated and in areas used by the assessment appraiser to formulate the fair value assessment of the land that is the subject of the leaseholder’s recreational lease”.

**Coming into force**

**7** These regulations come into force on the day on which they are filed with the Registrar of Regulations.

**SASKATCHEWAN REGULATIONS 96/2009***The Snowmobile Act*

## Section 41

Order in Council 736/2009, dated October 28, 2009

(Filed October 29, 2009)

**Title**

1 These regulations may be cited as *The Snowmobile Amendment Regulations, 2009*.

**R.R.S. c.S-52 Reg 1, section 6.8 amended**

2 **Subsection 6.8(1) of *The Snowmobile Regulations, 1998* is amended:**

- (a) **in clause (a) by striking out “\$40” and substituting “\$70”; and**
- (b) **in clause (b) by striking out “\$40” and substituting “\$70”.**

**Coming into force**

3(1) Subject to subsection (2), these regulations come into force on November 1, 2009.

(2) If these regulations are filed with the Registrar of Regulations after November 1, 2009, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
