## Section 16

Order in Council 792/2009, dated December 2, 2009

(Filed December 3, 2009)

**Title**

**1** These regulations may be cited as *The Water Power Rental Amendment Regulations, 2009*.

**R.R.S. c.W-6 Reg 2 amended**

**2** *The Water Power Rental Regulations* are amended in the manner set forth in these regulations.

**Section 2 amended**

**3** **Clauses 2(a) to (c) are repealed.**

**Section 3 amended**

**4** **Subsection 3(2) is repealed and the following substituted:**

“(2) The water rental payable pursuant to subsection (1) for each calendar year, commencing January 1, 2009, is the greater of:

- (a) \$0.25 per quarter year per kilowatt of generating capacity for the works calculated by multiplying the manufacturer’s KVA rating by the power factor as specified on the manufacturer’s specification plate on each generator; and
- (b) \$3.84006 per megawatt hour of power generated from the water used for the purpose of producing water power”.

<p>12. Non-cellular telephones and answering machines identified as a telecommunication device with a handset or headset that is used to transmit and receive sound, most commonly speech.</p>	<p>April 1, 2010</p>
