# SASKATCHEWAN REGULATIONS 43/2010

The Securities Act, 1988

# Section 154

### Commission Order, dated March 29, 2010

(Filed April 28, 2010)

Title

**1** These regulations may be cited as *The Securities Commission (Adoption of National Instruments) Amendment Regulations, 2010 (No. 4).* 

#### R.R.S. c.S-42.2 Reg 3 amended

**2** The Securities Commission (Adoption of National Instruments) Regulations are amended in the manner set forth in these regulations.

### Part III of Appendix amended

 $\mathbf{3}(1)$  Part III of the Appendix is amended in the manner set forth in this section.

# (2) Section 1.1 is amended by repealing the definition of "representative" and substituting the following:

"representative' means, for a participating dealer:

(a) a partner, director, officer or employee of the participating dealer;

(b) an individual who trades securities on behalf of the participating dealer, whether or not the individual is employed by the dealer; and

(c) any company through which a person referred to in paragraphs (a) or (b) carries on activities in connection with services provided to the participating dealer".

### (3) Section 1.2 is repealed and the following substituted:

**"1.2 Interpretation** - Terms defined in National Instrument 81-102 *Mutual Funds* and used in this Instrument have the respective meanings ascribed to them in National Instrument 81-102 *Mutual Funds*".

#### Part XXVI of Appendix amended

4 Subsection 1.1(1) of Part XXVI of the Appendix is amended in the definition of "mutual fund restricted individual" by striking out "salesperson, partner, director or officer of a dealer" and substituting "dealing representative of a registered dealer".

#### Part XLVI of Appendix amended

**5**(1) Part XLVI of the Appendix is amended in the manner set forth in this section.

# (2) Section 1.1 is amended by adding the following definition after the definition of "matching service utility":

"**'registered firm'** means a person or company registered under securities legislation as a dealer or adviser".

# (3) The heading to Part 4 is amended by striking out "REGISTRANTS" and substituting "REGISTERED FIRMS".

(4) Section 4.1 is amended by striking out "registrant" and substituting "registered firm":

- (a) in the portion preceding clause (a);
- (b) in clause (a); and
- (c) in clause (b).
- (5) Form 24-101F1 is amended:
  - (a) by striking out the following portion:

# Board Order, dated April 27, 2010

Title

1 These regulations may be cited as The Milk Control Amendment Regulations, 2010 (No.4).

#### R.R.S. c.M-15 Reg 1, Appendix amended

# 2 Clauses 3(1)(m) to (o) of Part II of the Appendix to *The Milk Control Regulations* are repealed and the following substituted:

- "(m) in the case of class 5a milk:
  - (i) \$3.4612 per kilogram of butterfat;
  - (ii) \$4.5420 per kilogram of protein;
  - (iii) \$0.4242 per kilogram of other solids;
- "(n) in the case of class 5b milk:
  - (i) \$3.4612 per kilogram of butterfat;
  - (ii) \$1.9594 per kilogram of protein;
  - (iii) \$1.9594 per kilogram of other solids;
- "(o) in the case of class 5c milk:
  - (i) \$3.8024 per kilogram of butterfat;
  - (ii) \$1.9594 per kilogram of protein;
  - (iii) \$1.9594 per kilogram of other solids".

#### **Coming into force**

# Section 83

# Minister's Order, dated April 27, 2010

#### Title

1 These regulations may be cited as *The Open Seasons Game Amendment Regulations*, 2010.

#### R.R.S. c.W-13.12 Reg 3 amended

**2** The Open Seasons Game Regulations, 2009 are amended in the manner set forth in these regulations.

### Section 14 amended

# **3** Subsection 14(2) is amended:

### (a) by repealing clause (a) and substituting the following:

"(a) in Wildlife Management Zones 1 to 14, 16 to 19, 21 to 25, 29 to 32, 35 to 38, 40 to 43, 45 to 55 and 68 South and in Fort a la Corne Wildlife Management Unit, from September 1 to October 31"; and

(b) in clause (b) by striking out ", Duck Mountain, and Moose Mountain" and substituting "and Duck Mountain".

#### Section 16 amended

#### 4 Clause 16(2)(a) is repealed and the following substituted:

"(a) in Wildlife Management Zones 1 to 14, 16 to 19, 21 to 25, 29 to 32, 35 to 38, 40 to 43 and 45 to 55, in Cypress Hills Inter-Provincial Park (West Block), in Saskatchewan Landing and Duck Mountain Provincial Parks, in that portion of Douglas Provincial Park lying west of Diefenbaker Lake (Gordon McKenzie Arm) and in Fort a la Corne Wildlife Management Unit, from October 1 to October 31".

#### Section 18 amended

#### **5** Clause 18(2)(b) is repealed and the following substituted:

"(b) in Wildlife Management Zones 1 to 14, 16 to 19, 21 to 25, 29 to 32, 35 to 38, 40, 41 and 45 to 47, in Cypress Hills Inter-Provincial Park (West Block), in Saskatchewan Landing and Duck Mountain Provincial Parks, in that portion of Douglas Provincial Park lying west of Diefenbaker Lake (Gordon McKenzie Arm) and in Last Mountain Lake National Wildlife Area, from November 15 to December 7".

#### Section 30 amended

#### 6 Subsection 30(2) is amended:

### (a) by repealing clause (a) and substituting the following:

"(a) in Wildlife Management Zones 1 to 19, 21 to 31, 34, 36, 40 to 47, 50 and 52 to 55, from September 1 to October 31"; and

(b) in clause (b) by adding ", in Saskatchewan Landing Provincial Park" after "(West Block)".

Section 58 amended

7(1) Subsection 58(1) is amended by adding "who holds a licence in accordance with Part VIII" after "Any person".

(2) Subsection 58(2) is amended by adding "who holds a licence in accordance with Part VIII" after "a person".

(3) Subsection 58(3) is amended by adding "mentioned in subsection (2)" after "No person".
