**SASKATCHEWAN REGULATIONS 51/2010***The Pharmacy Act, 1996*

## Section 52

Order in Council 281/2010, dated May 12, 2010

(Filed May 13, 2010)

**Title**

**1** These regulations may be cited as *The Drug Schedules Amendment Regulations, 2010*

**R.R.S. c.P-9.1 Reg 2 amended**

**2** *The Drug Schedules Regulations, 1997* are amended in the manner set forth in these regulations.

**Section 7 amended**

**3** **Subsection 7(1) is amended by striking out “*The Dental Profession Act, 1978*” wherever it appears and in each case substituting “*The Dental Disciplines Act*”.**

**New section 9.1**

**4** **Section 9.1 is repealed and the following substituted:**

**“Prescription privileges – pharmacists**

**9.1(1)** Subject to the *Controlled Drugs and Substances Act* (Canada) and the bylaws of the Saskatchewan College of Pharmacists, a licensed pharmacist may, subject to the terms, conditions and restrictions of his or her licence, prescribe any drug listed in Schedule I, II or III that is intended for the purpose of treating humans.

(2) A pharmacist who is licensed to prescribe drugs pursuant to a law of another jurisdiction in Canada providing for the granting of licences to pharmacists to practise their profession may, subject to the terms, conditions and restrictions of that licence, prescribe any drug listed in Schedule I, II or III that is intended for the purpose of treating humans”.

**Coming into force**

**5** These regulations come into force on the day on which they are filed with the Registrar of Regulations.

**SASKATCHEWAN REGULATIONS 52/2010***The Administration of Estates Act*

Section 51

**Title**

**1** These regulations may be cited as *The Administration of Estates Amendment Regulations, 2010*.

**R.R.S. c.A-4.1 Reg 1, section 6.1 amended**

**2** Clause 6.1(a) of *The Administration of Estates Regulations* is amended by striking out “\$150” and substituting “\$200”.

**Coming into force**

**3(1)** Subject to subsection (2), these regulations come into force on July 1, 2010.

(2) If these regulations are filed with the Registrar of Regulations after July 1, 2010, these regulations come into force on the day on which they are filed with the Registrar of Regulations.

**2** *L'alinéa 6.1a) du Règlement sur l'administration des successions est modifié par suppression de « 150 \$ » et son remplacement par « 200 \$ ».*

**SASKATCHEWAN REGULATIONS 53/2010***The Mandatory Testing and Disclosure (Bodily Substances) Act*

## Section 18

Order in Council 283/2010, dated May 12, 2010

(Filed May 13, 2010)

**Title**

1 These regulations may be cited as *The Mandatory Testing and Disclosure (Bodily Substances) Amendment Regulations, 2010*.

**R.R.S. c.M-2.1 Reg 1, new section 5.1**

2 **The following section is added after section 5 of *The Mandatory Testing and Disclosure (Bodily Substances) Regulations*:**

**“Prescribed functions**

5.1 For the purposes of subclause 3(1)(a)(iii) of the Act, the following are prescribed as functions respecting which an individual may apply to the court for a testing order:

(a) policing services provided by a member of a police service as defined in *The Police Act, 1990* or by a member of the Royal Canadian Mounted Police as defined in the *Royal Canadian Mounted Police Act (Canada)*;

(b) services provided by a paramedic, emergency medical technician or emergency medical responder pursuant to *The Paramedics Act* in the course of performing his or her duties;

(c) services provided by a firefighter to a fire department as defined in *The Fire Prevention Act, 1992*;

(d) correctional services as defined in *The Correctional Services Act* provided by:

(A) an employee or volunteer of a correctional facility within the meaning of *The Correctional Services Act*; or

(B) a probation officer as defined in *The Correctional Services Act*;

(e) youth justice services as defined in *The Youth Justice Administration Act* provided by a youth worker as defined in *The Youth Justice Administration Act*”.

**Coming into force**

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

Section 54

**1** These regulations may be cited as *The Public Guardian and Trustee Amendment Regulations, 2010*.

**R.R.S. c.P-36.3 Reg 1, section 14 amended**

**2** Clause 14(a) of *The Public Guardian and Trustee Regulations* is amended by striking out “\$150” and substituting “\$200”.

**Coming into force**

**3(1)** Subject to subsection (2), these regulations come into force on July 1, 2010.

(2) If these regulations are filed with the Registrar of Regulations after July 1, 2010, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
