SASKATCHEWAN REGULATIONS 99/2010

The Milk Control Act, 1992

Section 10

Board Order, dated September 10, 2010

(Filed September 13, 2010)

Title

1 These regulations may be cited as *The Milk Control Amendment Regulations, 2010 (No.9)*.

R.R.S. c.M-15 Reg 1, Appendix amended

2 Clauses 3(1)(m) to (o) of Part II of the Appendix to *The Milk Control Regulations* are repealed and the following substituted:

“(m) in the case of class 5a milk:

- (i) \$4.6689 per kilogram of butterfat;
- (ii) \$5.1610 per kilogram of protein;
- (iii) \$0.3901 per kilogram of other solids;

“(n) in the case of class 5b milk:

- (i) \$4.6689 per kilogram of butterfat;
- (ii) \$2.2454 per kilogram of protein;
- (iii) \$2.2454 per kilogram of other solids;

“(o) in the case of class 5c milk:

- (i) \$4.7342 per kilogram of butterfat;
- (ii) \$2.0859 per kilogram of protein;
- (iii) \$2.0859 per kilogram of other solids”.

Coming into force

3 These regulations come into force on October 1, 2010.
