### SASKATCHEWAN REGULATIONS 4/2011

#### *The Saskatchewan Assistance Act*

##### Section 14

Order in Council 88/2011, dated February 17, 2011

(Filed February 18, 2011)

##### Title

**1** These regulations may be cited as *The Disability Housing Supplement Amendment Regulations, 2011*.

##### R.R.S. c.S-8 Reg 8 amended

**2** *The Disability Housing Supplement Regulations* are amended in the manner set forth in these regulations.

##### New section 15.8

**3 The following section is added after section 15.7:**

##### “Transitional (2011)- eligibility for DHS benefits

**15.8(1)** In this section, ‘**qualifying client**’ means a client who:

(a) was receiving the DHS benefit before the coming into force of *The Disability Housing Supplement Amendment Regulations, 2011*; and

(b) as a result of the coming into force of *The Disability Housing Supplement Amendment Regulations, 2011* would no longer be eligible to receive the DHS benefit because the client’s monthly rent is less than the minimum qualifying rent set out in Table 1, 2, 3 or 4, as determined on the basis of the variables mentioned in subsections 11(3) to (6), as the case may be.

(2) Notwithstanding any other provision of these regulations, a qualifying client continues to be eligible to receive the DHS benefit until the client’s entitlement to receive the DHS benefit is terminated pursuant to section 32 on a ground other than that the client’s monthly rent is less than the minimum qualifying rent set out in Table 1, 2, 3 or 4, as determined on the basis of the variables mentioned in subsections 11(3) to (6), as the case may be”.

## Section 14

Order in Council 89/2011, dated February 17, 2011

(Filed February 18, 2011)

**Title**

**1** These regulations may be cited as *The Rental Housing Supplement Amendment Regulations, 2011*.

**R.R.S. c.S-8 Reg 7 amended**

**2** *The Rental Housing Supplement Regulations* are amended in the manner set forth in these regulations.

**New sections 11.8 and 11.9**

**3 The following sections are added after section 11.7:**

**“Transitional (2011) – eligibility for RHS benefits**

**11.8(1)** In this section, ‘**qualifying client**’ means a client who:

- (a) was receiving the RHS benefit on the day before the coming into force of *The Rental Housing Supplement Amendment Regulations, 2011*; and
  - (b) as a result of the coming into force of *The Rental Housing Supplement Amendment Regulations, 2011* would no longer be eligible to receive the RHS benefit because the client’s monthly rent is less than the minimum qualifying rent set out in Table 1 or Table 2, as determined on the basis of the variables mentioned in subsection 9(3) or (4), as the case may be.
- (2) Notwithstanding any other provision of these regulations, a qualifying client continues to be eligible to receive the RHS benefit until the client’s entitlement to receive the RHS benefit is terminated pursuant to section 28 on a ground other than that the client’s monthly rent is less than the minimum qualifying rent set out in Table 1 or Table 2, as determined on the basis of the variables mentioned in subsection 9(3) or (4), as the case may be.

**“Transitional (2011) - amount of RHS benefit**

**11.9(1)** In this section, ‘**qualifying client**’ means a category B client or category C client:

- (a) who was receiving the RHS benefit on the day before the coming into force of *The Rental Housing Supplement Amendment Regulations, 2011*;
  - (b) who was a member of an eligible family unit receiving SAP or TEA on the day before the coming into force of *The Rental Housing Supplement Amendment Regulations, 2011*; and
  - (c) whose RHS benefit would be reduced, as a result of the coming into force of *The Rental Housing Supplement Amendment Regulations, 2011*, by the amount of the SAP/TEA adjustment set out in Table 6, determined on the basis of the variables mentioned in subsection 11(4).
- (2) Notwithstanding any other provision of these regulations, a qualifying client’s RHS benefit continues to be reduced by the SAP/TEA adjustment set out in Table 6, determined on the basis of the variables mentioned in subsection 11(4), as that table existed on the day before the coming into force of *The Rental Housing Supplement Amendment Regulations, 2011*, until the client’s entitlement to receive the RHS benefit is terminated pursuant to section 28”.

## Section 27

Order in Council 90/2011, dated February 17, 2011

(Filed February 18, 2011)

**Title****1** These regulations may be cited as *The Child Care Amendment Regulations, 2011*.**R.R.S. c.C-7.3 Reg 2 amended****2** *The Child Care Regulations, 2001* are amended in the manner set forth in these regulations.**New section 3****3 Section 3 is repealed and the following substituted:****“Certain services excluded****3** For the purposes of clause 3(c) of the Act, the Act does not apply to services provided:

- (a) pursuant to *The Education Act, 1995*, *The Child and Family Services Act* or *The Residential Services Act*;
- (b) to children:
  - (i) where no one child receives the services for more than three hours per day;
  - (ii) where the service provided is of a therapeutic or medical nature delivered by a social or medical related organization; or
  - (iii) where the child’s parent is attending an educational or skills program on the same premises and is immediately accessible to attend to the needs of the child at all times;
- (c) to preschool or school-age children in the form of a children’s program if the person conducting the program satisfies the minister that the program will only be conducted on a seasonal basis or during holiday periods;
- (d) on a casual and irregular basis in the child’s residence or the residence of the person providing the services;
- (e) exclusively to school-age children on school premises;
- (f) in the form of a prekindergarten, kindergarten or Montessori program by any of the following, as defined in *The Education Act, 1995*:
  - (i) a board of education;
  - (ii) the conseil scolaire;
  - (iii) a registered independent school;

- (g) on a reserve as defined in the *Indian Act* (Canada); or
- (h) pursuant to the Government of Canada's Aboriginal Head Start in Urban and Northern Communities program".

**Section 76 amended**

**4 Subsection 76(2) is repealed and the following substituted:**

"(2) The maximum grant that may be made pursuant to subsection (1) is \$615 per child care space".

**Section 78 amended**

**5 Subsections 78(2) to (4) are repealed and the following substituted:**

"(2) The maximum grant that may be made pursuant to subsection (1) to the licensee of a full-time centre or a teen student support centre is:

- (a) \$616.67 per month per infant child care space;
- (b) \$370.00 per month per toddler child care space;
- (c) \$185.00 per month per preschool child care space; and
- (d) \$123.33 per month per school-age child care space.

"(3) The maximum grant that may be made pursuant to subsection (1) to the licensee of an extended hours centre that operates less than 120 hours per week is:

- (a) \$770.83 per month per infant child care space;
- (b) \$462.50 per month per toddler child care space;
- (c) \$231.25 per month per preschool child care space; and
- (d) \$154.17 per month per school-age child care space.

"(4) The maximum grant that may be made pursuant to subsection (1) to the licensee of an extended hours centre that operates 120 hours per week or more is:

- (a) \$925.00 per month per infant child care space;
- (b) \$555.00 per month per toddler child care space;
- (c) \$277.50 per month per preschool child care space; and
- (d) \$185.00 per month per school-age child care space".

**Section 87 amended**

**6 Subsections 87(1) and (2) are repealed and the following substituted:**

"(1) The minister may make a grant to a licensee of a facility for the reimbursement of tuition fees paid and required books purchased with respect to courses in early childhood education that are successfully completed by the licensee or a person employed in a facility:

- (a) for the purpose of meeting the requirements of these regulations; or
- (b) for the purpose of upgrading his or her qualifications as an early childhood educator.

“(2) The maximum grant that may be made pursuant to subsection (1) with respect to a person employed in the facility is:

(a) in the case of courses leading to qualification as an early childhood educator I, the greater of:

(i) \$500 per individual course taken by the person; and

(ii) \$1,500 for an early childhood educator orientation course that, in the opinion of the Director, is equivalent to the courses required to qualify as an early childhood educator I; and

(b) in the case of courses leading to qualification as an early childhood educator beyond the early childhood educator I level, \$500 per individual course taken by the person”.

**Coming into force**

**7** These regulations come into force on the day on which they are filed with the Registrar of Regulations.
