SASKATCHEWAN REGULATIONS 47/2011

The Wildlife Act, 1998

Section 83

Minister's Order, dated July 4, 2011

(Filed July 5, 2011)

Title

1 These regulations may be cited as *The Open Seasons Game Amendment Regulations, 2011*.

R.R.S. c.W-13.12 Reg 3 amended

2 *The Open Seasons Game Regulations, 2009* are amended in the manner set forth in these regulations.

Section 22 amended

3 **Clause 22(3)(b) is amended by adding** “in Wildlife Management Zone 33, in Moose Mountain Provincial Park,” **before** “in Wildlife Management Zone 6”.

Section 30 amended

4 **Subsection 30(2) is amended:**

(a) **by repealing clause (a) and substituting the following:**

“(a) in Wildlife Management Zones 1 to 6, 10, 13 to 15, 18, 19, 21 to 30, 40 to 42, 44 to 47 and 54, from September 1 to October 31”; **and**

(b) **in clause (b) by striking out** “in Cypress Hills Inter-Provincial Park (West Block),”.

Coming into force

5 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
