### SASKATCHEWAN REGULATIONS 36/2013

#### *The Municipal Grants Act*

##### Section 8

Order in Council 280/2013, dated May 15, 2013

(Filed May 16, 2013)

##### Title

**1** These regulations may be cited as *The Municipal Grants Amendment Regulations, 2013*.

##### R.R.S. c.M-28.1 Reg 1 amended

**2** *The Municipal Grants Regulations* are amended in the manner set forth in these regulations.

##### New section 6

**3 Section 6 is repealed and the following substituted:**

##### “Allocation of municipal revenue sharing grants

**6** Subject to sections 24 and 25, on and after April 1, 2013, the funding paid pursuant to section 5 must be allocated as follows:

- (a) 47.945% for cities;
- (b) 16.345% for urban municipalities;
- (c) 28.254% for rural municipalities;
- (d) 7.456% for northern municipalities, to be distributed in accordance with *The Northern Municipalities Regulations*”.

##### Section 9.1 repealed

**4 Section 9.1 is repealed.**

##### Section 16 amended

**5(1) Subsection 16(2) is amended by striking out “subject to subsections (3) to (5)” and substituting “subject to subsections (3) to (6)”.**

**(2) The following subsection is added after subsection 16(5):**

“(6) In the 2013-2014 fiscal year, with respect to a rural municipality that would receive a municipal revenue sharing grant greater than the amount it received in the 2010-2011 fiscal year, the amount of its grant is to be reduced by .011%”.

##### Coming into force

**6** These regulations come into force on the day on which they are filed with the Registrar of Regulations but are retroactive and are deemed to have been in force on and from April 1, 2013.
