### SASKATCHEWAN REGULATIONS 88/2016

#### *The Saskatchewan Employment Act*

Section 6-125

Order in Council 499/2016, dated November 18, 2016

(Filed November 18, 2016)

#### Title

1 These regulations may be cited as *The Labour Relations (Supervisory Employees) Amendment Regulations, 2016*.

#### RRS c S-15.1 Reg 4, section 3 amended

2 **Section 3 of *The Labour Relations (Supervisory Employees) Regulations* is amended:**

(a) **by renumbering it as subsection 3(1);**

(b) **by adding the following clause after clause (1)(c):**

“(d) foreman, general foreman and journey person in the construction industry”; **and**

(c) **by adding the following subsection after subsection (1):**

“(2) For the purpose of clause (1)(d), the construction industry:

(a) is the industry in which the activities of constructing, erecting, reconstructing, altering, remodelling, repairing, revamping, renovating, decorating or demolishing any building, structure, road, sewer, water main, pipeline, tunnel, shaft, bridge, wharf, pier, canal, dam or any other work or any part of a work are undertaken; and

(b) includes all activities undertaken with respect to all machinery, plant, fixtures, facilities, equipment, systems and processes contained in or used in connection with a work mentioned in clause (a), but does not include maintenance work”.

#### Coming into force

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.

**SASKATCHEWAN REGULATIONS 89/2016***The Pooled Registered Pension Plans (Saskatchewan) Act*

## Section 20

Order in Council 500/2016, dated November 18, 2016

(Filed November 18, 2016)

**Title**

1 These regulations may be cited as *The Pooled Registered Pension Plans (Saskatchewan) Amendment Regulations, 2016*.

**RRS c P-16.101 Reg 1, section 7 amended**

2 **Subsection 7(1) of *The Pooled Registered Pension Plans (Saskatchewan) Regulations* is repealed and the following substituted:**

“(1) The following are designated jurisdictions:

- (a) Quebec;
- (b) The Northwest Territories;
- (c) The Yukon Territory;
- (d) Nova Scotia;
- (e) British Columbia;
- (f) Nunavut;
- (g) Ontario”.
