### SASKATCHEWAN REGULATIONS 94/2016

#### *The Traffic Safety Act*

Subsection 287(5)

#### Minister's Order\*

#### Title

**1** These regulations may be cited as *The Vehicle Inspection Procedures Amendment Regulations, 2016*.

#### RRS c T-18.1 Reg 6, section 19 amended

**2** Subsection 19(1) of *The Vehicle Inspection Procedures Regulations, 2007* is repealed and the following substituted:

“(1) The following fees are payable:

- (a) \$175 per year for an inspection station certificate;
- (b) \$100 per year for an inspection mechanic certificate;
- (c) \$100 per year for a signing officer certificate”.

#### Coming into force

**3** These regulations come into force on the day on which they are filed with the Registrar of Regulations.
