## Section 16

Order in Council 839/2006, dated November 7, 2006

(Filed November 8, 2006)

**Title**

**1** These regulations may be cited as *The Water Power Amendment Regulations, 2006*.

**Sask. Reg. 906/68 amended**

**2** The Water Power Regulations, being Saskatchewan Regulations 906/68 as published in the Gazette of December 7, 1943 as a Schedule to Order in Council 1360/43, are amended in the manner set forth in these regulations.

**Section 1 amended**

**3** In section 1, the footnote to the definition of “Actual cost” is amended by striking out “See Sections 48(13) and 49(1)”.

**Section 48 repealed**

**4** Section 48 is repealed.

**Section 49 amended**

**5** Subsection 49(1) is amended in the third paragraph by striking out “in accordance with the provisions of subsections (13) and (14) of section 48”.

**Section 76 amended**

**6** Section 76 is amended by striking out “section 48” and substituting “*The Water Power Rental Regulations*”.

**Coming into force**

**7** These regulations come into force on the day on which *The Water Power Rental Regulations* come into force.
