### SASKATCHEWAN REGULATIONS 19/2007

*The Provincial Lands Act*

Sections 14 and 22

Order in Council 237/2007, dated March 27, 2007

(Filed March 28, 2007)

**Title**

1 These regulations may be cited as *The Provincial Lands Amendment Regulations, 2007*.

**Sask. Reg. 145/68, Part VIII amended**

2 **Part VIII of the Provincial Lands Regulations, being Saskatchewan Regulations 145/68, is amended by repealing Schedule Six and substituting the following:**

**“SCHEDULE SIX  
Surface Lease Fees and Rentals**

DESCRIPTION	AMOUNT
1. First Year Development Fee: (includes wellsites and roads)	
(a) cultivated land	
(i) first 3 acres	\$780 per acre
(ii) each subsequent acre	390 per acre
(iii) existing trail	195 per acre
(b) pasture land	
(i) first 3 acres	720 per acre
(ii) each subsequent acre	360 per acre
(iii) existing trail	180 per acre
2. Annual Surface Lease Rental: (includes wellsites and roads)	
(a) cultivated land	
(i) first 3 acres (min. fee is for 2 acres)	610 per acre
(ii) each subsequent acre	305 per acre
(b) pasture land	
(i) first 3 acres (min. fee is for 2 acres)	590 per acre
(ii) each subsequent acre	295 per acre

3. Multiple Well Heads	350 per head
4. Easements (one time charge)	
(a) cultivated land	780 per acre
(b) pasture land	720 per acre
5. Temporary Work Space (one time charge)	
(a) cultivated land	390 per acre
(b) pasture land	360 per acre
6. Battery Site (including roads)	
(a) first year development fee	780 per acre
(b) annual rental fee - first 3 acres	1350 per acre
(c) each subsequent acre	305 per acre
7. Surface Lease Amendment Fee	200".

**Coming into force**

3 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
