## UNREVISED REGULATIONS OF SASKATCHEWAN

### **SASKATCHEWAN REGULATIONS 100/2009**

The Provincial Lands Act

Sections 20 and 22

Order in Council 754/2009, dated November 13, 2009

(Filed November 13, 2009)

#### Title

1 These regulations may be cited as *The Provincial Lands Amendment Regulations*, 2009.

#### Sask. Reg. 145/68, section 1 of Part II amended

2 Subsection 1(5) of Part II of the Provincial Lands Regulations, being Saskatchewan Regulations 145/68, is repealed and the following substituted:

"(5) Notwithstanding subsection (3), the sale price of the leased lands sold in accordance with this section must be reduced as follows:

(a) if the lessee's application to purchase is received by the minister on or after November 15, 2008 and before January 1, 2011, by 10%;

(b) if the lessee's application to purchase is received by the minister in 2011, by 8%;

(c) if the lessee's application to purchase is received by the minister in 2012, by 6%;

(d) if the lessee's application to purchase is received by the minister in 2013, by 4%;

(e) if the lessee's application to purchase is received by the minister in 2014, by 2%".

**Coming into force** 

**3** These regulations come into force on the day on which they are filed with the Registrar of Regulations.
