SASKATCHEWAN REGULATIONS 70/2014*The Regional Health Services Act*

Section 64

Order in Council 434/2014, dated July 31, 2014

(Filed August 1, 2014)

Title

1 These regulations may be cited as *The Hospital Standards Amendment Regulations, 2014*.

Sask. Reg. 331/79 amended

2 The Hospital Standards Regulations, 1980, being Saskatchewan Regulations 331/79, are amended in the manner set forth in these regulations.

Section 1 amended

3 Section 1 is amended:

- (a) by repealing clause (a);
- (b) by repealing clause (p);
- (c) in clause (r) by adding “, mental health” after “rehabilitation”;
- (d) in clause (bb) by striking out “diagnostic, medical, surgical or rehabilitation services” and substituting “diagnostic, medical, surgical, rehabilitation or mental health services”; and
- (e) by repealing clause (hh).

Section 12 amended

4 Clause 12(3)(m) is amended by striking out “nurses’ notes” and substituting “any notes”.

Section 53 repealed

5 Section 53 is repealed.

Section 55.1 amended

6 Section 55.1 is amended in the portion preceding clause (a) by striking out “or a physician designated by the attending physician” and substituting “or nurse practitioner, or a physician or nurse practitioner designated by the attending physician or nurse practitioner”.

Section 58 repealed

7 Section 58 is repealed.

Coming into force

8 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
